# Management Discussion of Fund Performance

JUNE 8, 2021

This management discussion of Fund performance presents views of the portfolio management team about the significant factors and developments during the past year that have affected the Fund's performance and outlook.

## Investment Objective and Strategies

The Fund aims to provide an above-average income yield and long-term capital growth by investing primarily in debt and equity securities of Canadian corporations in various industries. The Fund intends to invest from 0% to 30% of its assets in foreign securities, but may invest up to 50%.

## Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for long-term investors looking for income with a growth component who have a low to medium tolerance for risk.

## Results of Operations

### CHANGES IN NET ASSETS

The Fund's net assets increased by 3.0% during the period to \$2.2 billion. This change was comprised primarily of gains from operations of \$645.8 million and a decrease of \$581.6 million due to net securityholder activity.

### FEES AND EXPENSES

The management expense ratios (MERs) for all series are generally similar to the MERs for the period ended March 31, 2020. Total expenses paid vary period to period mainly as a result of changes in average assets in each series.

### INVESTMENT PERFORMANCE

In accordance with National Instrument 81-106, the following comparison to one or more market indices has been included to help you understand the Fund's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Fund's mandate may be different from the index or indices shown. For a description of the index or indices, see *Annual Compound Returns*. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables.

For the returns of all series and for longer-term performance of the Fund, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the year ended March 31, 2021, the Series U securities returned 33.6% (after deducting fees and expenses paid by the Fund). In comparison, the S&P/TSX Composite Index (equity index) returned 44.2% and the FTSE Canada Universe Bond Index (fixed income index) returned 1.6%.

Canadian equities rebounded strongly over the period, reaching all-time highs after plunging earlier in 2020 over fears about the impact of the COVID-19 pandemic. Significant government and central bank stimulus both domestically and in the United States, Canada's largest trading partner, coupled with progress on vaccination programs in developed countries, led investors to factor higher levels of economic growth into equity valuations. The Bank of Canada maintained extraordinary monetary and fiscal policy measures, keeping its policy interest rate at 0.25% and making substantial bond purchases. Toward the end of the period, yields on 10-year government bonds increased to pre-pandemic levels.

Within the S&P/TSX Composite Index, consumer discretionary, information technology and health care were the strongest sectors, while communication services, consumer staples and utilities were the weakest.

The equity portion of the Fund outperformed the equity index, with stock selection in the materials and energy sectors contributing to performance. Stock selection in the information technology and health care sectors detracted from performance relative to the equity index.

The fixed income portion of the Fund outperformed the fixed income index, with an overweight exposure to corporate bonds and an underweight exposure to federal and provincial bonds contributing to performance.

Fund exposure to equities increased due to appreciation as markets rebounded from their low levels at the start of the period.

## Recent Developments

The equity portfolio management team believes Canada could experience robust economic growth later in 2021 and into 2022, fuelled by current and expected levels of stimulus spending and accelerating rates of COVID-19 vaccinations. If growth meets expectations, the team expects a positive impact on Canadian value-oriented cyclical sectors such as financials and energy and on the broad Canadian equity market.

The fixed income portfolio management team expects bond yields to remain elevated at the longer-term end of the yield curve in response to positive vaccination rates, economic expectations and the potential for higher inflation. The team expects the Bank of Canada to gradually reduce its asset-purchase program through 2021. However, uncertainty and volatility could affect fixed income markets in the event of further pandemic-related lockdowns that could delay economic growth. The team believes the low-duration, high-yield characteristics of the corporate bond market should generate attractive investment opportunities.

## Other Developments

### COVID-19

Governments worldwide have enacted various measures in seeking to combat the spread of the COVID-19 virus. These measures have led to significant volatility in equity markets and material disruption to businesses globally, resulting in an economic slowdown.

Ongoing uncertainty regarding the duration and long-term impact of the pandemic and the implementation of vaccination programs, as well as the efficacy of government and central bank monetary and fiscal interventions, may continue to affect the Fund's performance in future periods.

### UPCOMING MERGER

IG Wealth Management proposes to merge IG CI Canadian Balanced Fund into this Fund on or about June 18, 2021, with securityholder investments being switched into this Fund on a tax-deferred basis.

## Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor provided investment services to the Fund:

- Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities. A portion of the service fee for Series C and Tc is rebated by the Distributors to the Fund, for distribution to Series C and Tc securityholders quarterly, as outlined in the Prospectus.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Series Information* for the annual rates paid by each series (as a percent of average net assets) for these fees.

Securityholders in Series Tu and U also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

During the period, the Fund invested in other funds also managed by the Manager or affiliates of the Manager. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions.

Investment, if any, in unlisted open-ended funds managed by the Manager and/or affiliates of the Manager will be in series that do not pay fees. The exchange-traded funds (ETFs) into which the Fund may invest may have their own fees and expenses which reduce the value of the ETF. Generally, the Manager has determined that fees paid by an ETF are not duplicative with the fees paid by the Fund. However, where the ETF is managed by Mackenzie Financial Corporation, the ETF may distribute a fee rebate to the Fund to offset fees paid within the ETF.

During the period, the Fund received \$48,666 in income distributions from investments in ETFs managed by the sub-advisor to offset fees paid within the ETFs. There is no assurance that these distributions will continue in the future.

IGM Financial Inc. is a subsidiary of Power Corporation of Canada. Companies related to Power Corporation of Canada are therefore considered affiliates of the Manager. As at March 31, 2021, the Fund held the following investments in companies affiliated with the Manager: common shares of Power Corporation of Canada valued at \$14,193,982. The Manager relied on the standing instructions approved by the IG Wealth Management Funds Independent Review Committee for investment in related issuers. This investment represented 0.6% of the Fund's net assets.

Certain other investment funds, distributed by IG Wealth Management, and other qualified investors may invest in Series P or S of this Fund. As at March 31, 2021, these series comprised approximately 20.5% of the Fund's net assets. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions, which are based on the net asset value per security determined in accordance with the stated policies of the Fund on each transaction day. Investments by other investment funds in the Fund increase the risk of large redemption or purchase orders, which could result in larger than normal cash positions in the Fund for short periods of time. This could have an impact on the Fund's operations. However, the Manager uses various strategies to minimize the potential dilutive impact associated with large cash positions. These strategies may include transferring securities in-kind where possible, utilizing ETFs to maintain market exposure in lieu of cash and spreading transactions in smaller increments over a period of time.

The Manager has an investment in the Fund which, at March 31, 2021, was \$1,788 for Series T NL, \$1,291 for Series Tc and \$1,836 for Series T JNL.

## Management Fees

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Series Information* for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series U and Tu, securityholders pay the Distributors an advisory fee (separate from the management fee) directly. Therefore, the management fee in those series is used for investment advisory and management services only.

For all other retail series (i.e. which excludes Series F, P and S, if issued), approximately 59% of management fees paid during the period was used for investment advisory and management services, and approximately 41% related to distribution-related services. This may vary by series.

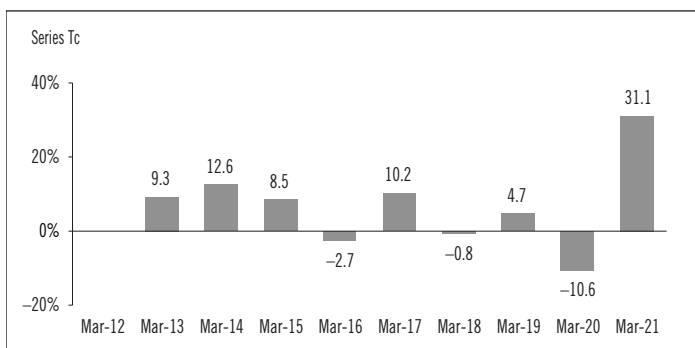
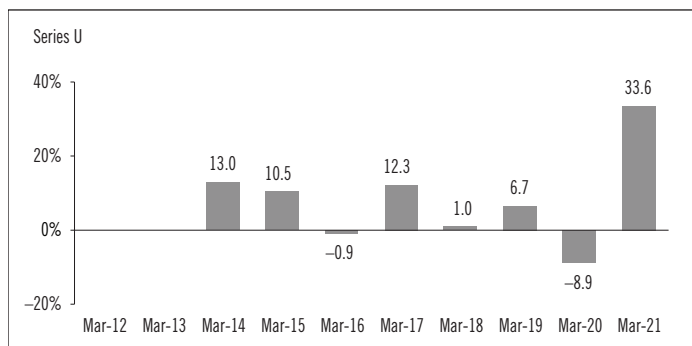
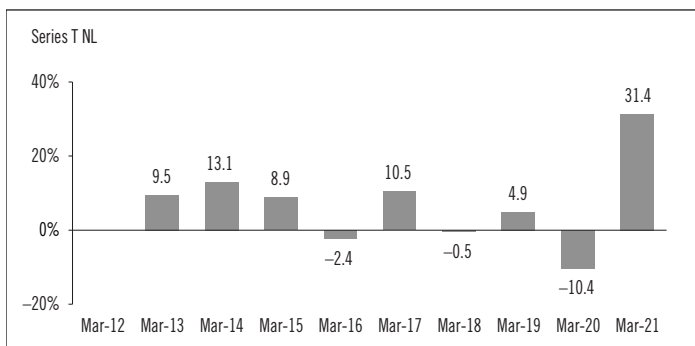
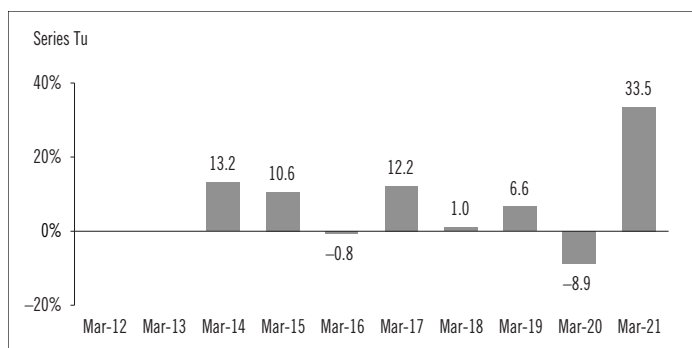
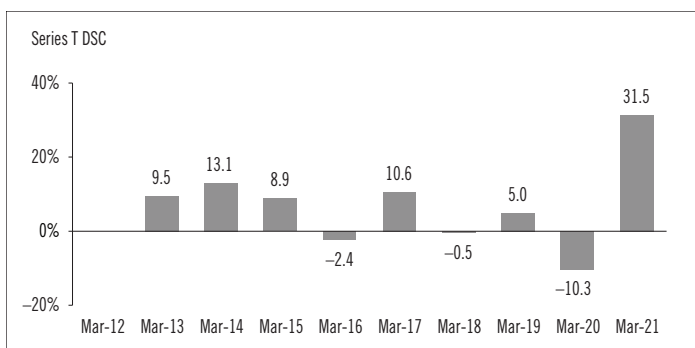
Performance during these periods may have been impacted by the following events:

- During some performance measurement periods, certain fees or expenses may have been waived or absorbed by the Manager or affiliates of the Manager. There is no assurance that fees will be waived in the future.
- Effective June 30, 2012, the annual management fee rate for Series A and B decreased by 0.30% to 1.70% and for Series C the rate decreased by 0.10% to 1.90%.
- Effective June 30, 2012, the annual service fee rate for Series B decreased by 0.05% to 0.40%.
- Effective January 1, 2017, the annual management fee rate for Series Tu and U decreased by 0.10% to 0.60%.
- Effective January 1, 2017, the annual service fee rate for Series B, J NL, T NL and T JNL decreased by 0.10% to 0.30%.

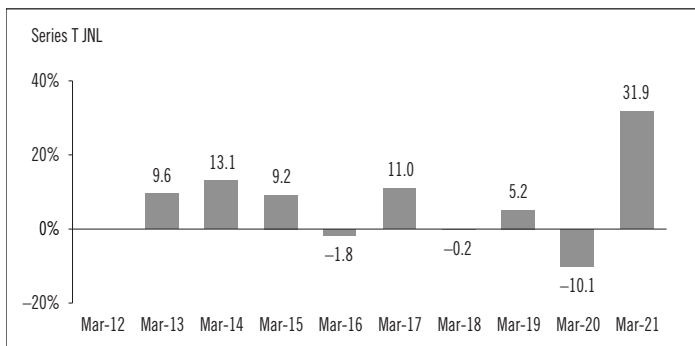
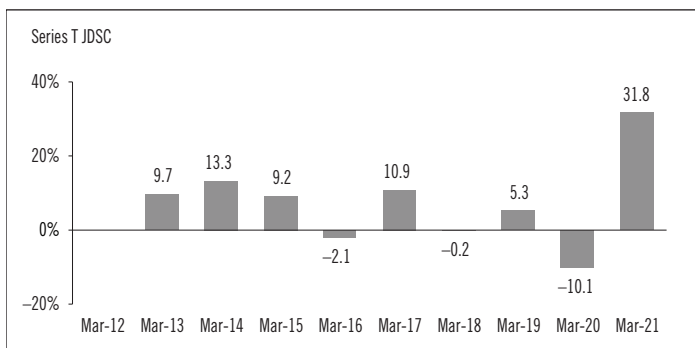
