Management Discussion of Fund Performance

June 6, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the year ended March 31, 2024 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Investment Objective and Strategies

The Fund aims to provide long-term capital growth by investing primarily in the common shares of Canadian corporations. Generally, the Fund will not invest more than 50% of its assets in foreign securities.

Risk

The risks of the Fund remain as discussed in the Fund's Simplified Prospectus.

The Fund is suitable for long-term investors looking for capital growth who have a medium tolerance for risk.

Results of Operations

Investment Performance

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

For the year ended March 31, 2024, the Series F securities returned 11.3% (after deducting fees and expenses paid by the Fund). In comparison, the S&P/TSX Composite Index returned 14.0%.

Canadian equities demonstrated resilience and positive momentum over the period, supported by the energy sector. Although the Bank of Canada paused interest rate increases after July 2023, the effects of earlier restrictive monetary policy, particularly on consumer finances, continued to work their way through the economy. With as much as 65% of gross domestic product related to consumer spending, flat consumer activity negatively affected economic growth.

Within the S&P/TSX Composite Index, information technology, health care and energy were the strongest sectors, while communication services, utilities and materials were the weakest.

The Fund underperformed the index, with stock selection in the consumer staples and information technology sectors and underweight exposure to the energy sector detracting from performance. Stock selection in Canada and holdings in Norway also detracted from performance. Underweight exposure to the materials sector and stock selection in the industrials sector contributed to performance, as did holdings in the United States and Finland.

Net Assets

The Fund's net assets increased by 18.0% during the period to \$596.8 million. This change was composed primarily of \$59.3 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$32.0 million due to net securityholder activity (including sales, redemptions and cash distributions). The securityholder activity includes an inflow of \$120.3 million relating to fund merger activity (see *Recent Developments*).

Fees and Expenses

The management expense ratio ("MER") for each series during the year ended March 31, 2024, was generally similar to the MER for the year ended March 31, 2023. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

The strength of the Canadian stock market rally toward the end of 2023 was largely the result of expectations that central banks would begin to reduce interest rates in 2024. However, the expected monetary easing did not take place in the first quarter, with investors shifting their focus to possible rate cuts later in the year. The Bank of Canada indicated in March that it is likely to reduce rates in 2024, but cautioned that it is reluctant to move too soon in light of persistent inflation. Many investors expect a shift to accommodative policy by the central bank to result in an economic "soft landing," avoiding a recession.

The portfolio management team's investment strategy involves identifying attractively valued shares of quality companies with strong fundamentals that it believes will prosper over the long term, regardless of economic cycles.

Other Developments

With the approval of the IG Wealth Management Funds Independent Review Committee, IG Beutel Goodman Canadian Equity Class merged into the Fund on May 19, 2023. The Manager does not consider this merger to be a material change for the Fund's investors.

Effective May 3, 2024, Series A was redesignated as Series B; and effective May 10, 2024, Series J DSC was redesignated as Series J NL.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities. A portion of the service fee for Series C is rebated by the Distributors to the Fund, for distribution to Series C securityholders quarterly, as outlined in the Prospectus.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

See *Fund Formation and Series Information* for the annual rates paid by each series (as a percentage of average net assets) for these fees.

Securityholders in Series F also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

IGM Financial Inc. is a subsidiary of Power Corporation of Canada. Companies related to Power Corporation of Canada are therefore considered affiliates of the Manager. As at March 31, 2024, the Fund held the following investments in companies affiliated with the Manager: common shares of Great-West Lifeco Inc. valued at \$4.7 million. The Manager relied on the standing instructions approved by the IG Wealth Management Funds Independent Review Committee for investment in related issuers. This investment represented 0.8% of the Fund's net assets.

The Manager relied on an approval issued by the IG Wealth Management Funds Independent Review Committee to proceed with the merger of IG Beutel Goodman Canadian Equity Class into the Fund on May 19, 2023.


Past Performance







Management Fees

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Fund Formation and Series Information* for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series F, securityholders pay the Distributor an advisory fee (separate from the management fee) directly. Therefore, the management fee in that series is used for investment advisory and management services only.

For all other retail series (i.e. those that exclude Series R, P and S, if issued), approximately 64% of management fees paid during the period was used for investment advisory and management services, and approximately 36% related to distribution-related services. This may vary by series.
