# Management Discussion of Fund Performance

### November 12, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the six-month period ended September 30, 2024 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

## **Results of Operations**

### **Investment Performance**

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Fund Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Fund's performance relative to the general performance of the markets. However, the Fund's mandate may be different from that of the indices shown.

For the six-month period ended September 30, 2024, the Series F securities returned 4.8% (after deducting fees and expenses paid by the Fund). In comparison, the ICE BofA Global Broad Market (Hedged) Index returned 3.9%.

In response to cooling inflation and weaker labour markets, the U.S. Federal Reserve, the European Central Bank and the Bank of England lowered interest rates during the period. The U.S. Federal Reserve reduced its federal funds rate by 50 basis points to a target range of 4.75%–5.00%. Global bond yields declined in anticipation of lower central bank rates. Meanwhile, the Bank of Japan raised its policy rate to 0.25% from zero, while indicating that it will consider additional increases depending on economic and inflation data.

The Fund outperformed the index, with duration management contributing to performance, particularly a longer duration (higher sensitivity to interest rates) in foreign government bonds, as interest rates fell. Holdings in corporate bonds in the energy sector also contributed to performance. Underweight exposure to corporate bonds in the securitization sector detracted from performance.

The portfolio management team increased the Fund's exposure to foreign government bonds over the period, particularly in the United States, based on their increased potential for capital gains as global central banks eased monetary policy. Exposure to Mexico was decreased as concerns about the new administration's ability to implement fiscal consolidation and a controversial judicial reform plan weighed on the Mexican peso and the country's credit rating.

## Environmental, Social and Governance ("ESG") Integration

The Fund added a new position in a green bond issued by the U.K. Treasury (United Kingdom Gilt, 0.88%, 07-31-2033) to help finance an expanded list of eligible projects in the government's new green bond framework.

## **Net Assets**

The Fund's net assets increased by 6.3% during the period to \$40.2 million. This change was composed primarily of \$1.7 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$0.7 million due to net securityholder activity (including sales, redemptions and cash distributions).

## **Fees and Expenses**

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2024, was generally similar to the MER for the year ended March 31, 2024. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

## **Recent Developments**

The portfolio management team believes that the U.S. Federal Reserve's rate cut aligned with market expectations and demonstrated the central bank's willingness to make significant moves in its policy stance when necessary. Because the team expects accommodative monetary policy to continue in response to weakening economic indicators, the team favours having duration exposure (sensitivity to changes in interest rates) in North America. In emerging markets, the team favours government bonds from South Africa over those from Brazil and Mexico as a result of the business-friendly coalition government formed in June, as well as improving economic data.

### **Other Developments**

Effective May 3, 2024, Series A was redesignated as Series B; and effective May 10, 2024, Series J DSC was redesignated as Series J NL.

Effective July 8, 2024, the Fund was renamed IG Mackenzie Global Tactical Bond Fund.

## **Related Party Transactions**

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Fund. The Fund is offered through the Advisors of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor provided investment services to the Fund:

Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Trustee is responsible for the overall direction of the affairs of the Fund. The Fund paid the Trustee a fee for its services.

Securityholders in Series F also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

During the period, the Fund invested in other funds also managed by the Manager or affiliates of the Manager. At September 30, 2024, the Fund had \$2.7 million (6.8% of the Fund's NAV) invested in underlying funds managed by Mackenzie. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions.

Investment, if any, in unlisted open-ended funds managed by the Manager and/or affiliates of the Manager will be in series that do not pay fees. The exchange-traded funds (ETFs) into which the Fund may invest may have their own fees and expenses which reduce the value of the ETF. Generally, the Manager has determined that fees paid by an ETF are not duplicative with the fees paid by the Fund. However, where the ETF is managed by Mackenzie Financial Corporation, the ETF may distribute a fee rebate to the Fund to offset fees paid within the ETF.

During the period, the Fund received \$0.002 million in income distributions from investments in ETFs managed by the sub-advisor to offset fees paid within the ETFs. There is no assurance that these distributions will continue in the future.




## Year-by-Year Returns

Where the Fund directly invests in securities of another fund (including exchange-traded funds or "ETFs"), the MERs presented for the Fund include the portion of MERs of the other fund(s) attributable to this investment. Any income distributions received from ETFs managed by affiliates of the Manager, with the intention of offsetting fees paid within those ETFs but which are not considered to be duplicative fees under regulatory requirements, are treated as waived expenses for MER purposes. The Manager may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.
- (3) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs incurred as an annualized percentage of daily average net assets during the period. Where the Fund invests in securities of another fund (including ETFs), the TERs presented for the Fund include the portion of TERs of the other fund(s) attributable to this investment.

The value of any trades to realign the Fund's portfolio after a fund merger, if any, is excluded from the portfolio turnover rate.

## **Management Fees**

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Fund Formation and Series Information* for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series F, securityholders pay the Distributor an advisory fee (separate from the management fee) directly. Therefore, the management fee in that series is used for investment advisory and management services only.

For all other retail series (i.e. those that exclude Series R, P and S, if issued), approximately 55% of management fees paid during the period was used for investment advisory and management services, and approximately 45% related to distribution-related services. This may vary by series.

# **Fund Formation and Series Information**
