## Management Discussion of Fund Performance

November 12, 2024

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Pool's performance and outlook in the six-month period ended September 30, 2024 (the "period"). If the Pool was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Pool. In addition, net asset value ("NAV") refers to the value of the Pool as calculated for transaction purposes, on which the discussion of Pool performance is based.

## **Results of Operations**

### **Investment Performance**

The performance of all series in the current and previous periods is shown in the *Past Performance* section of the report. Performance will vary by series primarily because fees and expenses differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. Please refer to the *Pool Formation and Series Information* section of this report for the varying management and administration fees payable by each series. The following comparison to market indices is intended to help investors understand the Pool's performance relative to the general performance of the markets. However, the Pool's mandate may be different from that of the indices shown.

For the six-month period ended September 30, 2024, the Series I securities returned 5.8% (after deducting fees and expenses paid by the Pool). In comparison, the MSCI World (Net) Index returned 9.0% and the FTSE World Broad Investment-Grade Bond Index returned 5.5%.

Global equity markets generally rose over the period. Share prices increased in relation to corporate earnings, with gains in U.S. markets driven mainly by a small number of mega-capitalization stocks. The global economy was resilient as inflation continued to slow across most major markets, although unemployment moved slightly higher. The U.S. Federal Reserve, the European Central Bank and the Bank of England lowered interest rates, and global bond yields declined. The U.S. Federal Reserve reduced its federal funds rate by 50 basis points to a target range of 4.75%–5.00%. Meanwhile, the Bank of Japan raised its policy rate to 0.25% from zero.

Within the MSCI World (Net) Index, Asia Pacific (ex Japan) and North America were the best-performing regions in Canadian dollar terms, while Japan, Europe, and Africa and the Middle East were the weakest. The utilities, information technology and real estate sectors were the strongest performers, while energy, consumer discretionary and health care were the weakest.

The Pool outperformed the FTSE World Broad Investment-Grade Bond Index, in part because of exposure to global equities. The Pool underperformed the MSCI World (Net) Index, in part because of exposure to fixed income securities.

iShares Core S&P/TSX Capped Composite Index ETF, representing about 14% of net assets at the end of the period, was the largest contributor to Pool performance. iShares MSCI Brazil ETF, which was eliminated during the period, was the largest detractor from performance.

Over the period, the Pool's exposure to U.S. bonds decreased and exposure to Canadian dollar cash holdings increased, based on the portfolio management team's assessment of valuations and opportunities.

### Net Assets

The Pool's net assets increased by 14.1% during the period to \$687.3 million. This change was composed primarily of \$38.5 million in net income (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$46.6 million due to net securityholder activity (including sales, redemptions and cash distributions).

### **Fees and Expenses**

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2024, was generally similar to the MER for the year ended March 31, 2024. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

### **Recent Developments**

The portfolio management team believes that central bank monetary easing, fiscal support and a strong labour market can continue to support an elevated level of economic growth, despite bond prices recently reflecting a higher likelihood of a slowing U.S. economy. In this environment, the Pool maintains overweight exposure to equities and underweight exposure to fixed income investments.

In the equity portion of the portfolio, the Pool has overweight exposure to emerging markets, primarily Taiwan, which are well positioned to benefit from artificial intelligence (AI) trends. It has overweight exposure to U.S. equities to take advantage of the cash flow strength and healthy earnings of U.S. companies. However, the portfolio management team recently reduced the U.S. position because of the risk of heightened volatility related to the November U.S. presidential election. It moved to an underweight position in Canadian equities from overweight exposure in the expectation of weaker corporate earnings growth. Holdings in Spain were reduced as equity prices moved closer to the team's targets and investments in Australia increased on expectations of improving share prices.

## **Related Party Transactions**

I.G. Investment Management, Ltd. is the Manager, Trustee and Portfolio Advisor of the Pool. The Pool is offered through the Advisors of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor, Distributors and Trustee are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The Pool paid a pool advisory fee to the Portfolio Advisor for investment management and portfolio advisory services (see *Management Fees*).

The Pool also paid the Manager an administration fee for administrative services.

The Trustee is responsible for the overall direction of the affairs of the Pool. The Pool paid the Trustee a fee for its services.

See *Pool Formation and Series Information* for the annual rates paid by each series (as a percentage of average net assets) for these fees.

Certain other investment funds, distributed by IG Wealth Management, and other qualified investors may invest in Series P of this Pool. As at September 30, 2024, this series comprised approximately 51.1% of the Pool's net assets. The Manager relied on standing instructions approved by the IG Wealth Management Funds Independent Review Committee for the execution of all such transactions, which are based on the net asset value per security determined in accordance with the stated policies of the Pool on each transaction day. Investments by other investment funds in the Pool increase the risk of large redemption or purchase orders, which could result in larger than normal cash positions in the Pool for short periods of time. This could have an impact on the Pool's operations. However, the Manager uses various strategies to minimize the potential dilutive impact associated with large







## **Management Fees**

The Pool pays a pool advisory fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Pool Formation and Series Information* for rates payable by each series). The pool advisory fees pay the costs incurred to provide investment management services. The Manager waived a portion of pool advisory fees to ensure returns remained competitive.

Securityholders in the iProfile Program also pay a program advisory fee directly to the Distributors. This fee is not included in the Pool's expenses. Distribution-related services were paid for out of the program advisory fee and other revenue sources.

Series I and Series Ti securities are offered to investors investing a minimum of \$200 who hold their investments in an iProfile account with an initial minimum household investment of \$250,000 through the iProfile Program. Investors in Series Ti securities also wish to receive a steady, monthly cash flow from their investment.

Series P securities are offered exclusively to mutual funds managed by IGIM (or its affiliates) and certain institutional investors in connection with fund-of-fund arrangements.
