Management Discussion of Fund Performance

November 14, 2022

This Management Discussion of Fund Performance presents the portfolio management team's view on the significant factors and developments that have affected the Fund's performance and outlook in the six-month period ended September 30, 2022 (the "period"). If the Fund was established during the period, "period" represents the period since inception.

In this report, "IGIM" and "the Manager" refer to I.G. Investment Management, Ltd., the manager of the Fund. In addition, net asset value ("NAV") refers to the value of the Fund as calculated for transaction purposes, on which the discussion of Fund performance is based.

Results of Operations

Investment Performance

In accordance with National Instrument 81-106, the following comparison to one or more market indices has been included to help you understand the Fund's performance relative to the general performance of the markets. However, the portfolio management team cautions that the Fund's mandate may be different from the index or indices shown. Also, it is important to note that investors cannot invest in an index. Indirect investments in an index are available; however, there are fees and transaction costs and other variables that will impact returns when investing in these products. Index returns included in the comparison below do not reflect these costs and variables.

For the returns of all series and for longer-term performance of the Fund, see the *Past Performance* section of this report. Performance will vary by series primarily because fees and expenses may differ between series, or because securities of a series were not issued and outstanding for the entire reporting period. See *Series Information* for the annual expense rates for each series.

For the six-month period ended September 30, 2022, the Series F (formerly Series U) securities returned -15.5% (after deducting fees and expenses paid by the Fund). In comparison, the Fund's broad-based indices, the S&P/TSX Composite Index and S&P/TSX SmallCap Index, returned -14.4% and -22.8%, respectively. The Fund's narrow index, the S&P/TSX Completion Index, returned -15.4%. Given the Fund's mandate, the narrow index has been included as a more meaningful comparison.

Canadian equities fell over the period, driven by rising interest rates and volatile commodity prices. Energy prices were relatively high, bolstered by the ongoing Russia-Ukraine war. Employment numbers remained strong. Consumer spending also continued to be resilient, supporting the consumer discretionary and consumer staples sectors.

Within the S&P/TSX Composite Index, consumer staples, consumer discretionary and energy were the strongest sectors, while health care, information technology and real estate were the weakest.

Canadian small-capitalization stocks generally underperformed large-capitalization stocks. Within the S&P/TSX SmallCap Index, information technology, consumer staples and utilities were the strongest sectors, while communication services, materials and financials were the weakest.

Canadian mid-capitalization stocks generally performed in line with large-capitalization stocks. Within the S&P/TSX Completion Index, energy, utilities and financials were the strongest sectors, while health care, information technology and materials were the weakest.

As at September 30, 2022, substantially all the net assets of the Fund were invested in IG Mackenzie Canadian Small/Mid Cap Fund (the Underlying Fund).

The Underlying Fund underperformed the S&P/TSX Composite Index, with stock selection in the financials sector and overweight exposure to the real estate sector detracting from performance. Conversely, overweight exposure to the industrials sector and an underweight position and stock selection in the information technology sector contributed to performance relative to the S&P/TSX Composite Index.

The Underlying Fund outperformed the S&P/TSX SmallCap Index because of its exposure to mid-cap stocks, which outperformed small-cap stocks in the period.

The Underlying Fund performed in line with the narrow index, with stock selection in the industrials and materials sectors contributing to performance. Conversely, stock selection in the financials sector and underweight exposure to the energy sector detracted from performance relative to the narrow index.

Net Assets

The Fund's net assets decreased by 10.8% during the period to \$15.2 million. This change was composed primarily of \$2.7 million in net losses (including any interest and/or dividend income) from investment performance, after deducting fees and expenses, and an increase of \$0.9 million due to net securityholder activity (including sales, redemptions and cash distributions).

Fees and Expenses

The annualized management expense ratio ("MER") for each series during the period ended September 30, 2022, was lower than the MER for the year ended March 31, 2022, due to a decrease in the management fee rates effective June 28, 2022, as noted in the *Series Information* section of the report. Total expenses paid vary from period to period mainly as a result of changes in average assets in each series. The MERs for all series are presented in the *Financial Highlights* section of this report.

Recent Developments

The economic outlook remains clouded by uncertainty related to the slowdown in consumer demand from earlier pandemic-related highs. Inflationary pressures together with strong employment trends have led central banks to raise policy interest rates. The war in Ukraine continued to push energy and food prices higher. All these factors weighed on equity market valuations. However, the portfolio management team of the Underlying Fund remains cautiously optimistic regarding the long-term prospects for Canadian equities. At period-end, stocks were less expensive, market sentiment was less euphoric, and the team believed valuations had become more attractive across most areas of the market.

Other Developments

Effective June 28, 2022, the annual management fee rates for Series A, B, F (formerly U), J DSC and J NL decreased by 0.15%.

Related Party Transactions

I.G. Investment Management, Ltd. is the Manager and Portfolio Advisor of the Fund. The Fund is offered through the Consultants of Investors Group Financial Services Inc. and Investors Group Securities Inc., together referred to as the Distributors. The Manager, Portfolio Advisor and Distributors are, indirectly, wholly owned subsidiaries of IGM Financial Inc.

The following sub-advisor provided investment services to the Underlying Fund:

- Mackenzie Financial Corporation

Mackenzie Financial Corporation is a wholly owned subsidiary of IGM Financial Inc.

The Fund paid a management fee to the Manager and Portfolio Advisor for management and portfolio advisory services (see *Management Fees*).

The Fund also paid the Manager an administration fee and in exchange the Manager paid the operating costs and expenses of the Fund, except for certain specified costs.

The Fund paid the Distributors a service fee as compensation for providing or arranging for the provision of services to the Fund, including the issue or allotment of securities.

Securityholders in Series F (formerly Series U) also pay an advisory fee directly to the Distributors. This fee is not included in the Fund's expenses.

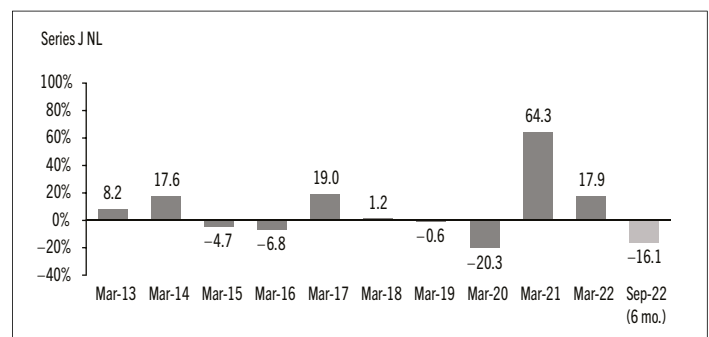
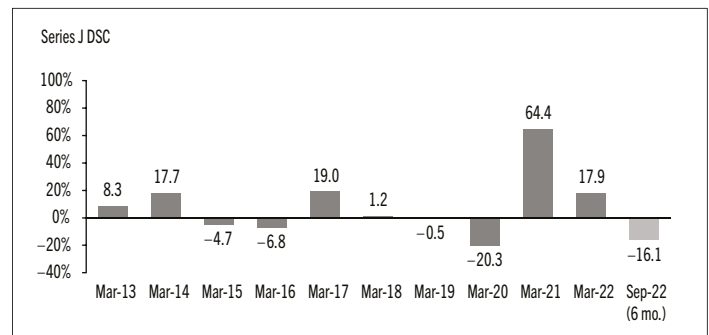
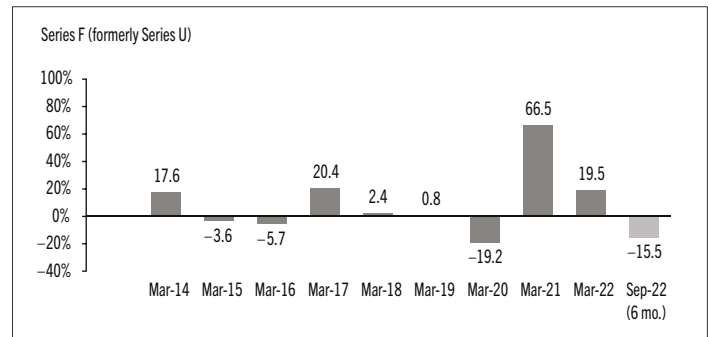
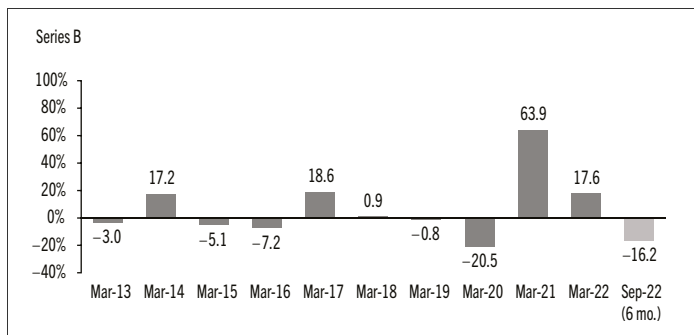
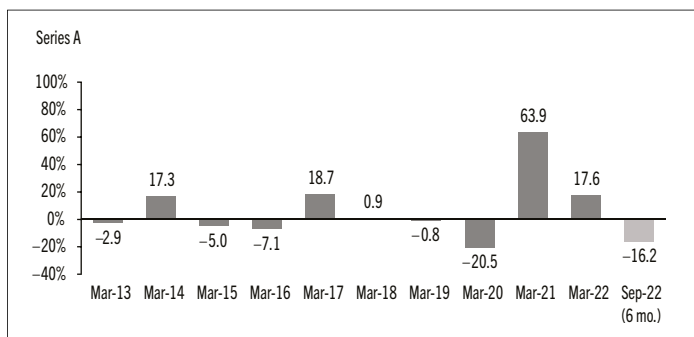
During the period, the Fund invested substantially all of its assets in another IG Wealth Management Fund. There is no duplication of fees incurred by the Fund in connection with these investments.

Past Performance

Performance during these periods may have been impacted by the following events:

- The Fund changed its investment objective and strategies to invest primarily in securities of Investors Canadian Small Cap Growth Fund and/or directly in equity securities, on June 12, 2013.
- Effective February 4, 2019, the Fund changed its investment objectives and strategies to expand exposure to small and mid-cap Canadian companies and broaden investment management diversification opportunities. To achieve its investment objective, the Fund intends to continue to invest up to 100% of its net assets in units of the IG Mackenzie Canadian Small/Mid Cap Fund.

In the period a series is established, the MER is annualized from the date of inception to the end of the period. Where the Fund directly invests in securities of another fund (including exchange-traded funds or "ETFs"), the MERs presented for the Fund include the portion of MERs of the other fund(s) attributable to this investment. Any income distributions received from ETFs managed by affiliates of the Manager, with the intention of offsetting fees paid within those ETFs but which are not considered to be duplicative fees under regulatory requirements, are treated as waived expenses for MER purposes. The Manager may waive or absorb operating expenses at its discretion and stop waiving or absorbing such expenses at any time without notice.
- (3) The trading expense ratio ("TER") represents total commissions and other portfolio transaction costs incurred as an annualized percentage of daily average net assets during the period. Where the Fund invests in securities of another fund (including ETFs), the TERs presented for the Fund include the portion of TERs of the other fund(s) attributable to this investment.
- (4) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. The higher the Fund's portfolio turnover rate in a period, the greater the trading costs payable by the Fund in the period, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund. The portfolio turnover rate is not provided when the Fund is less than one year old. The value of any trades to realign the Fund's portfolio after a fund merger, if any, is excluded from the portfolio turnover rate.

Management Fees

The Fund pays a management fee, and this fee, paid by each series, is calculated as a percentage of the net asset value of the series at the close of each business day (see *Series Information* for rates payable by each series). Generally, management fees pay the costs incurred to provide investment advisory and management services, as well as distribution-related services provided by the Distributors.

However, in the case of Series F, securityholders pay the Distributor an advisory fee (separate from the management fee) directly. Therefore, the management fee in that series is used for investment advisory and management services only.

For all other retail series (i.e. those that exclude Series R, P and S, if issued), approximately 66% of management fees paid during the period was used for investment advisory and management services, and approximately 34% related to distribution-related services. This may vary by series.
