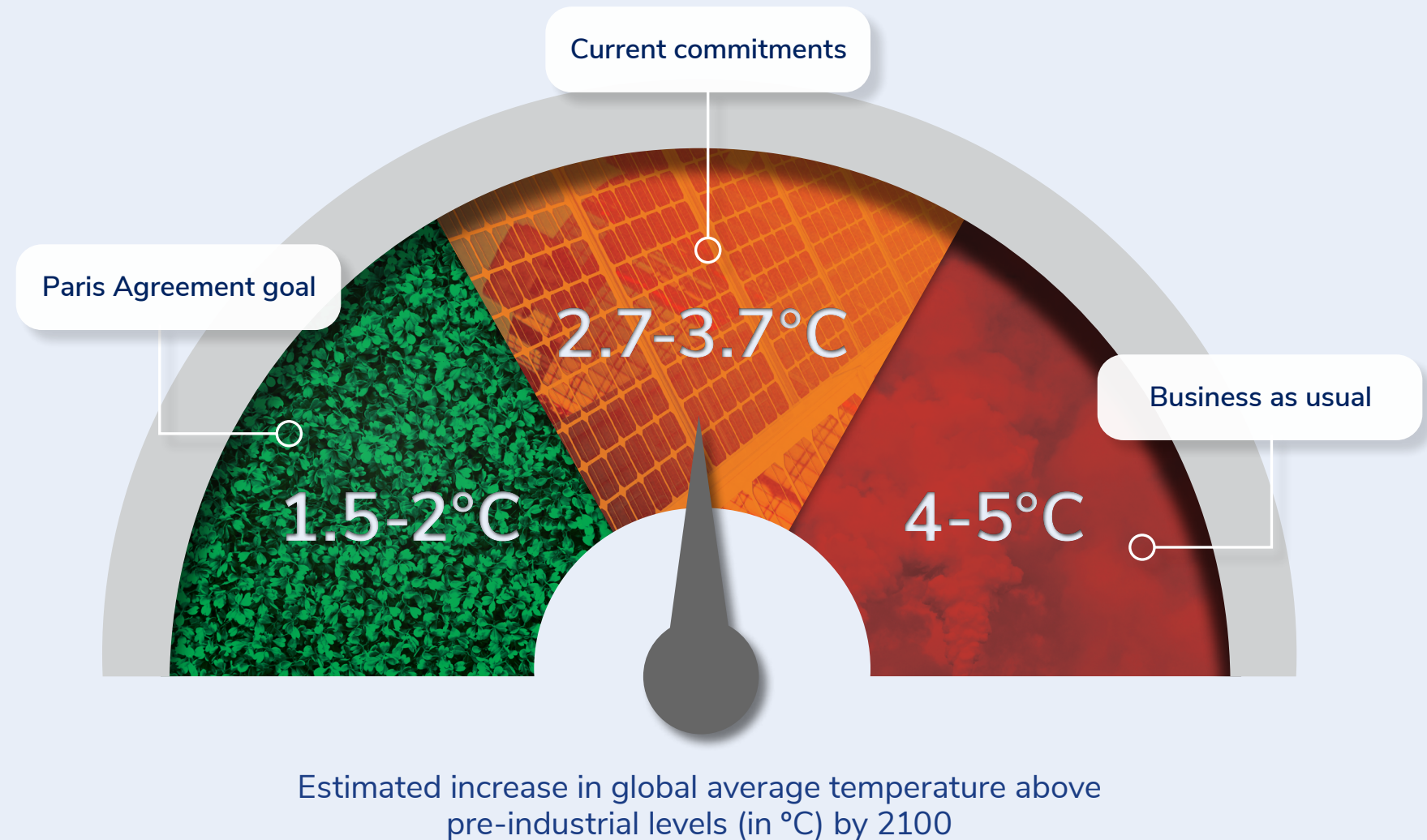

A global push to net zero

It's now well recognized that the Paris Agreement's goal of limiting global warming to 2°C above pre-industrial levels by the end of the century isn't enough. To negate the more devastating impacts of climate change, scientists have determined that as a planet we must reach net-zero greenhouse gas emissions by 2050 and limit the global temperature increase to 1.5°C. One hundred and thirty-nine plus countries have set targets to reach net zero by 2050, including Canada.

Accelerated action will be required to meet the goals set forth by the Paris Agreement.



The places where authorities have set, or have proposed to set, a target of bringing carbon emissions to net zero by mid-century, represents:

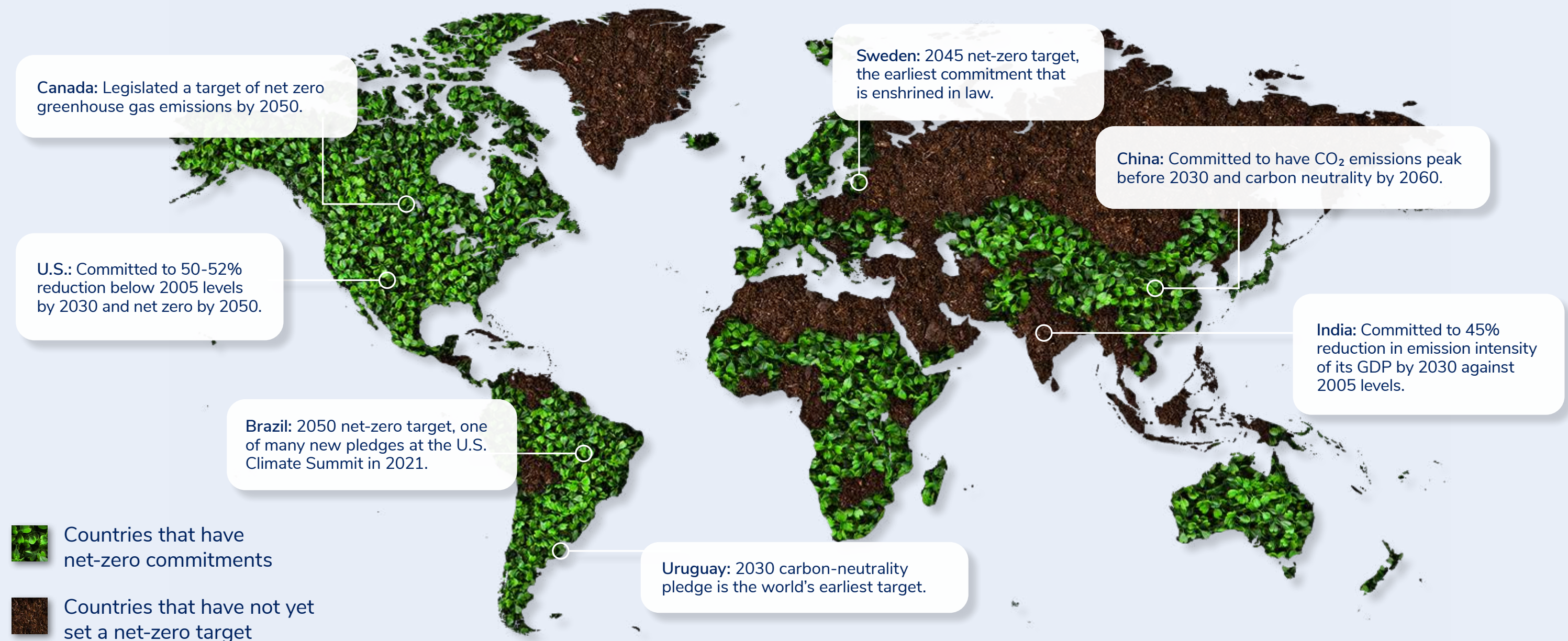
83% of global emissions

Net-zero commitments taking hold and growing

Net zero has gone from an obscure scientific concept to being a focal point in halting climate change. Of the 139 countries that have made the net-zero pledge, some have already turned it into law, while others are working toward it.



The beginning of a once-in-a-generation economic shift

Reaching net zero will involve a seismic shift in the global economy, a lot of capital investment, and could generate tremendous investment opportunities.

An estimated US\$90 trillion¹ of investment is needed between now and 2050 to transform infrastructure, industries, sectors and companies, to create a sustainable future. In the shorter term, it is estimated that bold climate action could deliver at least US\$26 trillion² in economic benefits by 2030, compared to business as usual.

As the push towards a net-zero economy accelerates, one thing is certain: the future will look nothing like what we've experienced in the past. The transition will create new jobs that demand huge investment and evolve infrastructure, businesses and how we live our lives.

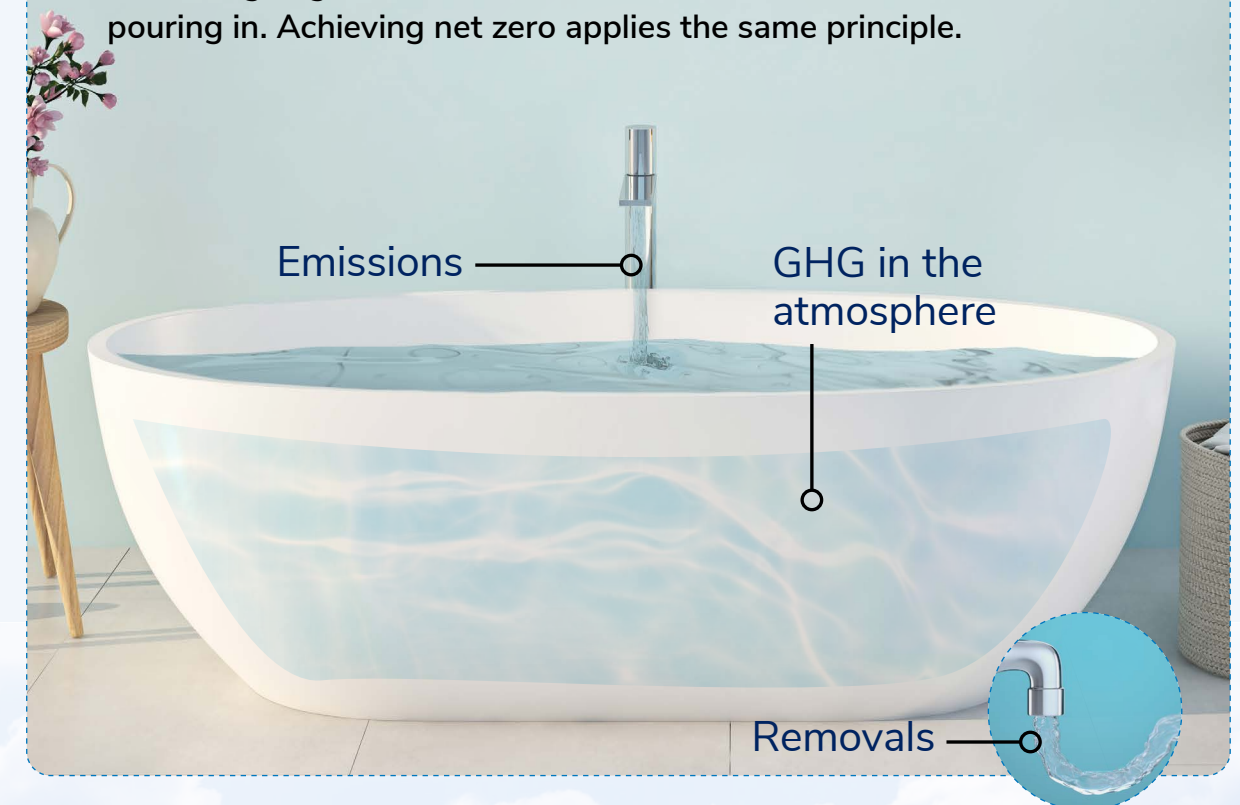

What is net zero?

Net zero strikes a balance between the greenhouse gases (GHG) going into the atmosphere and those being taken out. Using the analogy of running a bath, the amount of water in a bathtub is determined by the input (water from the tap) and the output (water leaving via the drain). To balance the water level, the amount of water going down the drain must be the same as the amount pouring in. Achieving net zero applies the same principle.

Investment strategy

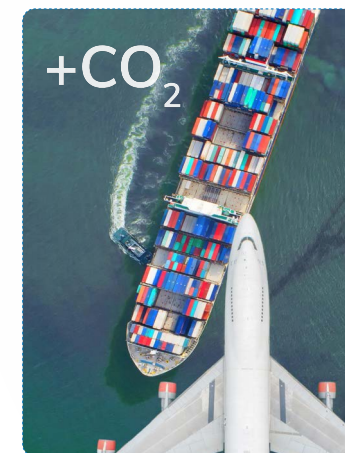
IG Climate Action Portfolios are designed to provide exposure to one or more of the following types of climate-related approaches:

- 01 **Best-in-class investing:** In companies with leading climate policies and practices.
- 02 **Help fuel the transition:** Invest in companies or products that are helping advance the green transition.
- 03 **Bypass GHG emissions:** Avoid high greenhouse gas emitters and invest in funds that focus on lower-carbon intensive sectors.
- 04 **Active climate stewardship:** Engage with company management and utilize proxy voting to prioritize climate policies and outcomes.

Offsetting strategy

The portfolios will seek to reduce the greenhouse gas emissions from the underlying investments.

Evaluate portfolio for any residual greenhouse gas emissions



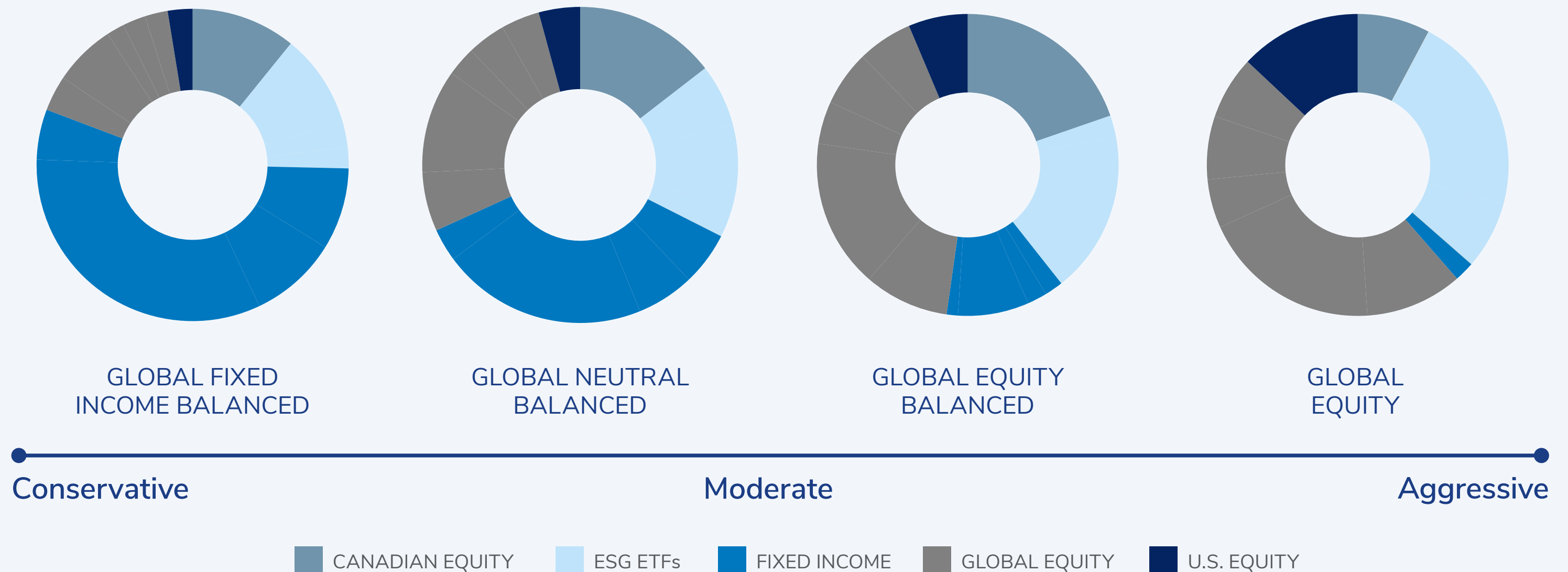
